Executive **Summary**

NEW BOARD OF DIRECTORS AND FISCAL COMMISSION

The new authorities were elected during the 2016 Annual Assembly of Representatives held on March 10 in Bogotá, Colombia.

Mr. Carlos Colo, Executive Manager of Exploration and Development of YPF, was chosen to serve as Chairman of the Board of Directors of the Association for the period 2016-2017. Mr. Colo is a geologist with more than 30 years of experience in exploration and production. He has been in charge of the exploration of Vaca Muerta. He previously served in YPF as Director of E&P Technical Directorate, Director of Las Heras Economic Unit, and General Manager in Colombia.

The Representatives elected ANCAP -after chairing the Board- and re-elected Pluspetrol to first and second Vice-Chairs, respectively. These positions are held by Benito Piñeiro and Roberto Díaz.

The Board of Directors is also made up of other seven member companies: EP-Petroecuador, Petrobras, Repsol, Petroperú, Recope, Spectrum and Weatherford.

In addition, a decision was made also on the composition of the Fiscal Commission for the period 2016-2018. It will be made up of the following representatives: ENAP, acting as Chair, Schlumberger and IHS-Markit.

STRATEGIC GUIDELINES FOR SUSTAINABLE ENERGY DEVELOPMENT



Reciprocal Assistance and Innovation Operational and Management Excellence



Exploration and Production Committee

The Exploration and Production Committee continued with its line of work in reservoir management and process safety through the organization of technical congresses called Meetings of Experts (RANEs), which allow placing professionals in the frontier of knowledge of the topics addressed. In addition, activities were carried out to share the way in which companies have improved their efficiency to remain competitive in the new global energy scenario.

87th RANE **Process Safety in E&P Operations**

This event held on March 9-10 in Bogotá was organized based on the need to address safety of offshore operations, leadership development and culture, impact of operations and relations with the community. The event attracted the attention of more than 100 executives and specialists from 11 countries of the region.







88th RANE **Reservoir Management**

The congress was held on November 9-10 in Lima, with the support of Petroperú and the Peruvian Society of Hydrocarbons (SPH, under its acronym in Spanish). It brought together professionals, technicians and academic researchers specialized in the area, who exchanged experiences, presented case studies and analyzed the latest technologies with regard to integrated reservoir management.



The change in the price scenario forced companies to drastically change their management, with the improvement of efficiency becoming a crucial point to maintain competitiveness. In this regard, the extension of the useful life of the reservoirs and the optimization of productivity throughout the life cycle are key to the efficiency of a company, and hence the importance and relevance of the event. This is one of the lines of work of the Committee, and another RANE on this subject has already been announced for 2018.

Associated with the RANE on Reservoir Management, the Workshop **How to Remain Profitable in an Environment of Low Oil Prices?** was held on November 11. This event was an opportunity for exchange among professionals from almost 20 companies who shared the different alternatives and paths followed by the companies to maintain their levels of profitability in the new energy scenario.







Fostering innovation

On the occasion of the opening of the facilities of Y-TEC in Berisso, Province of Buenos Aires, on September 29, the **Regional Meeting of R&D Centers** was held. As innovation is the key pillar of competitiveness and business development in the long term, and also one of the strategic lines of work of the Association, this event was called and organized in collaboration with Y-TEC, with high-level international and regional speakers sharing strategies and tools for the development and application of new knowledge. The conclusions of the meeting were useful for the

preparation of one of ARPEL key projects for 2017: the implementation of a technological collaboration platform gathering the demand and supply of technology for the oil and gas industry in Latin America and the Caribbean. The conclusions of this event are available on our website in the report entitled **Technological Cooperation as a Pillar of the Development of the Oil and Gas Industry in Latin America and the Caribbean.**









Pipelines and Terminals Committee

The Pipelines and Terminals Committee continued its work on infrastructure integrity with a focus on the monitoring and inspection of geohazards, best practices for pipeline inspections, the optimization of the operation of terminals and the development of a shared database on statistics about failure in pipelines and rights of way.



Guideline on "Monitoring and inspection in pipeline integrity management against geothreats"

The document was published in August and summarizes more than one year of hard work of the regional project team designated for such purpose. It documents the best practices and lessons learned in the monitoring and inspection of pipelines, rights of way and triggering agents of land instability processes that may threaten pipeline integrity. Geohazards are the main cause of breakage of pipelines in our region, and this work is a great contribution to raise the standards of pipeline management and reduce the number of incidents. The management of geohazards is one of the lines of work of the Committee, so the group is still active and devoted to the development of a second version of the guidelines on the subject, to the dissemination of the first document and to the organization of meetings and exchange of experiences.

Workshop "In-Line Inspection (ILI) data analysis for pipelines"

The event was held on October 5-6 in Mexico City under the sponsorship of PEMEX. The purpose of the workshop was to share experiences and good practices regarding the maintenance of pipeline infrastructure through the management of in-line inspections. Among the main topics covered were the regulations, the need to establish a

process and a multidisciplinary team to manage adequately the inspection and maintenance, inspection through PIGs, the alternatives in case pigging is not possible, the management of specific threats, such as stress corrosion cracking or illegal taps, as well as specific experiences of companies from Mexico, Colombia, Brazil, Bolivia, Chile, Ecuador, Peru and Argentina.



Database of failures in pipelines

Sharing the experience gained by member companies in an increasingly open and interconnected world is key to accelerate the learning curve and optimize the management of the integrity of the assets, in addition to providing a significant reduction in costs. In this regard, the Committee decided to set up this database in order to reduce the number and impact of incidents in pipelines in a cooperative manner.

Cross-checks

The traditional cross-checks were carried out during the year. These activities consist in a technical visit and a critical analysis of an oil terminal operated by a company, by a group of professionals of another company, based on ARPEL Reference Manual for Terminals Operation Management. The two companies that led the checks were Pluspetrol, which offered its terminal in Pisco, and Petropar, which opened the doors of its terminal in Villa Elisa. The results of both checks are summarized in a document and enable the identification of gaps and pave the way for the development of plans for improvement.

Guideline on "Fire Protection Systems in Transportation and Storage Facilities"

This document, published in April, is a technical point of reference with a didactic approach, accredited by a group of experts from the region, for the administration, implementation, optimization and maintenance of fire protection systems in facilities for onshore transportation of oil, considering economic and technical standards and best practices in the industry. The working team is dedicated to providing training on the implementation of best practices, and to the development of checklists to facilitate their use.





Committee on Health, Safety and Environment

The Committee on Health, Safety and Environment continued with its line of work in performance benchmarking, with the support of its Occupational Health Working Group and with the dissemination of good practices for oil spill response prevention and planning.

BENCHMARKING

In order to continue supporting the improvement in the management and performance of the oil and gas industry in Latin America and the Caribbean in the field of environment, health and safety, statistical manuals were updated during 2016, incorporating new indicators, and new editions of the annual performance reports were issued.

The main developments in this regard were that in 2016 we began the compilation of indicators of emissions of greenhouse gases, and progress was also made in the criteria to report on process safety indicators.

OCCUPATIONAL HEALTH

Psychosocial Risks



The Guideline for Addressing the Evaluation of Psychosocial Risk Factors in the Workplace was published in response to the need for our companies to incorporate knowledge and tools for the evaluation of psychosocial risk factors, an emerging issue in the oil and gas industry in Latin America and the Caribbean, and in the labor legislation. This guideline establish criteria and recommendations for early detection and management of potential damage to which the worker is exposed due to psychosocial risk factors. This document was developed under the leadership of Ecopetrol, one of the most advanced companies in this field, and complements the work of the Health Working Team, which in 2014 had already published other guidelines with the purpose of facilitating the monitoring of psychosocial risk factors. Work on the implementation of this guideline in member companies will begin in 2017.

Vector-borne diseases

On the basis of the outbreaks of contagious diseases occurring in the past few years, and in particular those transmitted by vectors such as zika, dengue, chikungunya, malaria and Chagas' disease, with a high prevalence in the region, the Health Team worked on this issue and performed the translation into Spanish and Portuguese of the document "Vector-borne disease management programmes, a guide for the oil and gas industry", developed by IPIECA and IOGP in 2012. The document provides a set of criteria to establish the prevention of this type of diseases, and it is a contribution to the industry in the region and the community.

OIL SPILL PREVENTION AND RESPONSE

Update and translation into French and Portuguese of the Manual and RETOS Tool

The Oil Spill Response Planning and Readiness Assessment Manual and its Assessment Tool RETOS, developed in 2011 and updated in 2014 and 2016, have become an international reference on this subject, and are currently used by companies and governments in the five continents. In turn, to facilitate the international scope of the tool and its use in different regions of the globe, this year the manual and its Excel tool were translated into French (with funds from the International Oil Spill Conference) and Portuguese.



Dissemination of the RETOS Tool

During 2016, in addition to the training courses conducted, this tool was presented at the **3rd Latin American Congress and 5th National Congress on Occupational Health, Safety and Environment Congress in the Hydrocarbons Industry** (Argentina, IAPG), at the **Symposium on Oil Spills** (Petroleum Association of Japan) and the **Association collaborated in organizing the Regional Workshop on Oil Spill Contingency Planning** (Bahamas, IMO). This last event served to train delegates from governments of 12 countries and assess the national contingency plans of each of these countries. On the other hand, a course on the tool RETOS has been confirmed as a side event to the International Oil Spill Conference in 2017.



Human Talent and Knowledge Management Committee

The Human Talent and Knowledge Management Committee works on the exchange and on the fomentation of best practices and experiences that promote the development of human, intellectual and organizational capital of the industry in the region, this being one of the most relevant topics for the sector at present.

Benchmarking Report on "Knowledge Management"

The report consisted in a survey conducted to referents in human talent in member companies, and aimed to identify how to work on issues related to knowledge management and innovation, how they are inserted in the corporate culture, how tacit and explicit knowledge is managed, as well as to identify common practices, best practices and gaps to improve and to establish a network of knowledge that may lead to strengthen the management of this issue in the oil and gas industry.

Benchmarking Report on "Human Talent Management"

With the same spirit of the Benchmarking Report on Knowledge Management, a Benchmarking Report on Human Talent Management was developed aimed to provide relevant information on how oil and gas companies in the region are managing different aspects of HR management. The questions were addressed to the current context, the evolving needs of talent, attraction and recruitment techniques, communication and participation, training and knowledge management, background, retention and long-term commitment, diversity management, working conditions and compensation plans and recognition.

Webinar "Best Practices/ Lessons Learned in Cost-Reduction Programs"

The webinar "Best Practices/Lessons Learned in Cost-Reduction Programs" was held on November 29. The sharp decline in oil prices caused by imbalances in the global offer had a great impact on the market that led oil & gas companies to quickly adjust their operating models. This made the leaders focus on solving the business requirements through different strategies to reduce cost and improve efficiency. The webinar sought to address these strategies, what their impact on the management of companies has been, and how the future is envisioned. It was presented by professionals from Repsol, Ecopetrol and YPF who have led these processes.



E-Learning

In order to put the potential of new information technologies and communications at the disposal of the training required by the sector, an instructional design was developed according to the educational trends, new learning needs and quality parameters of the Association. ARPEL VIRTUAL seeks to position itself in the



LAC and global training context because of the relevance and quality of its proposals for the sector of oil, gas and biofuels, and the companies in general. This approach allows saving costs and reaching a greater number of professionals in the sector.



Social Responsibility Committee

The Social Responsibility Committee addresses issues of high sensitivity and importance for the development of the oil industry. These issues include human rights, relations with communities and indigenous peoples, management of social risks, gender and cultural diversity and labor practices.

Corporate Social Responsibility (CSR) Management System

The updated version of the Corporate Social Responsibility (CSR) Management System was published in August and is available on our website. This management system provides conceptual and practical guidance on this issue and comprises a set of interrelated documents -framework documents, thematic manuals and tools- that facilitate the introduction, implementation and training on the issue adopting a comprehensive and holistic paradigm that includes environmental, social, and cultural factors. The system is a reference at the international level and is the only system developed specifically for the oil & gas industry.



Online course on "Business and Human Rights"

An online course on Business and Human Rights was developed and given for the first time with the support of professionals of the Regional Center for Responsible Businesses and Entrepreneurship (CREER under its acronym in Spanish). Its purpose is to introduce and provide basic tools of analysis on the subject to personnel at all levels of hydrocarbon companies. It was also a milestone in the development of online training, being the first of its kind to be offered by the Association.

Management of Environmental Impacts of the Oil and Gas Industry and the Rights of Children

In June, a memorandum of understanding was signed with UNICEF in order to make a report on the management of the potential environmental impacts of the industry on the rights of children. Through case



studies, the review of corporate policies, regulatory frameworks and scientific evidence, it seeks to generate knowledge to improve the practices of due diligence and the management of potential impacts on children. At the end of the year, work was done on the last stage of the project, and the final report is expected to be published in the first quarter of 2017.

Webinar on "Anti-Corruption and Fraud"

Following the line of work against corruption, the Webinar on Anti-Corruption and Fraud was held in May in association with the KPMG Global Energy Institute in Latin America. The talk was aimed at C-level executives, and its main objective was to share the main trends on how companies are dealing with international rules and regulations to combat corruption and corporate fraud, to analyze the factors that contribute to the incidence of these activities, and to facilitate the development of risk management strategies, with a view to its eradication in the organizations.

Support to the Implementation of the CSR Management System in YPFB

During 2016, support was provided to YPFB in the definition of the basic CSR concepts, alignment of the business model and policies of the organization with CSR, with the baseline implementation framework and with the management framework of the company. Training was also provided for a diagnosis of the main CSR topics, mapping of stakeholders and risk analysis.

Report of cases of relations with Indigenous Peoples

In the framework of the extensive work carried out by the Association with respect to the relations of the industry with the indigenous peoples in the region, a document that contains the experience of ARPEL member companies was developed. Its purpose is to share lessons learned and recommendations to promote a greater understanding of this issue, and to improve the knowledge to facilitate the processes of the industry where this issue needs to be addressed as a matter of high social sensitivity.





Refining and Fuels Committee

The work of the Refining and Fuels Committee was focused on the exchange of experiences and best operational practices, with the aim of improving efficiency and competitiveness, and raising the standards of performance in environment, health and safety.

Workshop on "Best Practices in Energy Management"

Energy efficiency is currently considered a new source of energy because of its potential to increase the energy available to be finally used without increasing inputs or losing quality in the services. At a time when climate change and competitiveness are key issues for business continuity in the hydrocarbons industry, the Workshop on Best Practices in Energy Management was held in Buenos Aires. The two-day event brought together 150 professionals from the region to exchange experiences, best practices and the implementation of the latest solutions and technological innovations in the field, in addition to carrying out a guided visit to the La Plata Refinery.



Workshop on "Best Practices in FCC units"

Within the framework of the 50th anniversary of the Bío Bío refinery, a workshop on FCC units operation was organized with the support of ENAP. This was the first activity of its kind organized in Latin America, where more than 120 professionals from eleven refineries in Argentina, Chile, Colombia, United States, Peru, Uruguay and Venezuela participated.

During three days, these professionals exchanged experiences and information on best operational practices in catalytic cracking units and analyzed the challenges faced by the oil industry, and especially the refining industry in Latin America and the Caribbean, to operate its production units efficiently and ensure competitiveness. New management tools available to minimize the impact on the environment, and the safety of operations and workers were also discussed during the workshop.

As a close to the event, the participants visited the operating facilities of the Bío Bío Refinery.





CYBERSECURITY

The Cybersecurity Working Group began its work by the end of 2015 as a team composed of the most senior specialists on the subject of major oil and gas companies in Latin America and the Caribbean, in order to reduce

the vulnerabilities of the industry to face an emerging and highly potential threat.

In this regard, a **baseline survey** was carried out to determine the situation of companies with regard to cybersecurity, and the **Webinar "Business Cybersecurity, Concepts and Challenges"** was held in June. The talk was conducted by Jeimy Cano, Ecopetrol expert and professor at Universidad de los Andes.

The main activity of the year was the **Seminar on Cybersecurity in Critical Infrastructures in a Technologically Dependent and Interconnected World.** Organized by the Cybersecurity Working

Group with the support of OAS and the Government of Argentina through the Ministry of Modernization and the Ministry of Foreign Affairs and Worship of the Republic of Argentina, this event was held October 18-19 at the Palacio San Martín in Buenos Aires.

This two-day event brought together 200 professionals from the sectors of Information Technology (IT) and Operations Technologies (OT), as well as experts and high-level governmental authorities. The main issues





on the agenda were the analysis of the challenges posed by emerging cybersecurity threats for infrastructure integrity, in addition to the latest technologies and methodologies applicable to face them. The conclusions of the event were compiled in a document with the same title as that of the event, which is available on ARPEL website. Among the key messages are that cybersecurity is an emerging and growing threat, with high potential for damage, and implies a change in the concept of risk analysis and mitigation strategies, cooperation among public and private actors, and a closer connection between the IT and OT areas.

Climate Change Resilience

The Group on Climate Change, established at the end of 2015, aims to analyze the environment and improve the capacity of understanding of member companies regarding the **vulnerability**, **risks and opportunities** arising from climate change as important elements for the strategic management of the business sustainability.



First Meeting of the Working Group on Climate Change

The first meeting of the Working Group on Climate Change was held in November at the offices of the Executive Secretariat in Montevideo. Participants from ten companies shared their experiences on how they are addressing this subject in each company and country in the region. As a conclusion to the meeting, a number of activities were raised to work on three lines of action: raising senior management awareness, vulnerability and risk analysis, and standardization of methodologies to develop GHG emission inventories.

Dissemination and analysis of the results of the Conferences of the Parties (COP)

The Paris Agreement, which was reached after the COP21 in December 2015, is undoubtedly the most relevant international milestone in recent years with regard to the mitigation of and adaptation to climate change. This Agreement and the results of the COP, has great impacts on the oil and gas industry in the region. For this reason, the report "The Paris Agreement and the Oil and Gas Industry" was prepared. This report summarizes for the senior management the most significant aspects of the above-mentioned agreement for the industry. Work has already begun on the report on COP22, which will be published in January 2017.





Webinar "Zero Routine Flaring by 2030"

The Webinar "Zero Routine Flaring by 2030", organized together with the Global Gas Flaring Reduction Initiative was held in July. This initiative, led by Secretary General of the United Nations, Ban Ki-Moon, and World Bank President, Jim Kim, and already endorsed by more than 50 governments, companies and multilateral organizations, seeks to eliminate the existing legacy of routine flaring by 2030, and help to ensure that field development plans for new oil fields include a utilization solution for the use of gas without routine flaring or venting. The webinar, attended by member companies, was presented by Francisco Sucre, Regional Coordinator of the Global Gas Flaring Reduction partnership of the World Bank, with the aim of disseminating the initiative and seeking synergies and opportunities for improvement of the performance of the industry in this matter.

Contribution of ARPEL to International Initiatives

In December, ARPEL participated in a workshop held in Colombia for the promotion of the Climate and Clean Air Coalition (CCAC). This international public-private coalition aims to reduce the emission of short-lived pollutants (methane, carbon, and others) and has a specific initiative focused on oil and gas, whose objective is the reduction of methane and carbon emissions in our industry. This workshop was the starting point for the approach and the search for synergies between ARPEL and the CCAC, and it is expected that dissemination and awareness actions will be materialized for our region and sector in 2017.

Promotion of Research

In order to encourage and strengthen research in the regional energy sector, and to disseminate this knowledge among the academic community, a contest was organized, together with OLADE, entitled "What is being done with the gas associated to oil in Latin America and the Caribbean?" This competition brought together researchers and experts of the hydrocarbons sector to develop a scientific article on "Venting and Flaring of Gas Associated with Oil in Latin America and the end of the year, four finalist papers were selected, and the winner will be selected in the early months of 2017. The prize will consist in an economic compensation for research, entry to the Oil and Gas Regional Conference ARPEL 2017 and a course offered by ARPEL of the winner's choice.

Energy Integration Expansion of Markets and Energy Security

Report on "Trends of the Natural Gas Sector in LAC"

The Gas and Energy Committee developed the above-mentioned report in order to analyze the regional situation of the natural gas market, as well as the potential impact of large infrastructure projects in progress, the new international dynamic of LNG, the complementarity with the electricity sector, mainly with renewable energy, and the technological advances that allow the development of new markets such as LNG on a small scale. One of the most important conclusions of this paper is the need to continue to work on the harmonization of regulations that facilitate and optimize gas flows among the countries in the region, many of them already interconnected and with idle capacity. Precisely this last issue will be the main line of action of the Committee during 2017.



Regional Energy Agenda

Work continued on the Regional Energy Agenda along with ALADI, CAF, ECLAC, CIER, OAS, OLADE and WEC during 2016. In relation to the PRESER Project, several documents were prepared on National Strategic Security: "The International Framework and the Socio-Economic and Energy Developments in the Region at the Level of Countries and Subregions," "Economic



and Energy Scenarios for South American Countries," "Identification of Strategic Projects for the Regional Energy Security in South American Countries" and "Argentina: Prospects of Natural Gas Supply." Ten priority projects for the oil sector and ten projects for the electricity sector were also selected, which include the profile of each project and its economic, social and environmental analysis.

Technical Advocacy Regulations Enabling Investments



White Paper on unconventional hydrocarbons

With the aim of sharing the most relevant aspects relating to the exploration and exploitation of unconventional hydrocarbons (shale oil/gas/tight), the white paper establishes a series of proposals for sustainable development and for the benefit of the countries in the region, the document "Opportunities for the Development of Unconventional Oil and Gas in Latin America and the Caribbean" was drawn up. This document is based on extensive scientific evidence and intends to provide technical rigor to the debate on the social and environmental impact of hydraulic stimulation techniques, in matters such as induced seismicity, use of water or use of chemical additives.

The document was widely disseminated to the main relevant governmental authorities in the region, as well as representatives of companies, research institutes, chambers and industry associations, professional associations, international organizations, the academia and the civil society.

Multi-Institutional Ad-Hoc Group in Uruguay (ACEPH, WPC-UY, ARPEL)

The Association of Oil Exploration and Production Companies (ACEPH), the Uruguayan Committee of the World Petroleum Council (WPC-UY) and ARPEL established an ad-hoc collaboration group to openly share the accumulated knowledge on legislation, best practices, technological and socio-environmental management, with the Uruguayan authorities, and to facilitate the sustainable development of the hydrocarbons industry in this country. In this regard, several meetings were held with high-level authorities of the Uruguayan Government to advise on the sustainable development of unconventional reservoirs.

Workshop on "Experiences in Management of Hydrocarbons in Producing Countries"

To support the Ministry of Industry, Energy and Mines and the National Energy Authority of Uruguay, the Workshop "Experiences in Management of Hydrocarbons in Producing Countries" was co-organized with the support of ACEPH and the Uruguayan Committee of the WPC. The event brought together the highest authorities and technical staff of the aforementioned governmental bodies, specialists from companies that are conducting exploration activities in Uruguay, speakers of the Argentine Institute of Oil and Gas (IAPG), the Economic Commission for Latin America (ECLAC) and international consulting firms. The objective of the workshop was to share best practices on governance of natural resources, taxation of extractive industries and the proper management of communication and expectations in a potentially new industry.

Sustainability Reports and Communication Transparency and Reputation

Confirming the commitment of the Association to social and environmental sustainability, **the support to the Economic and Social Council of the United Nations and the consultative status of ARPEL were ratified** after submitting the quadrennial report. This report summarizes the activities carried out by the Association to promote the economic and social sustainability, and the Sustainable Development Goals that were defined in 2015 and will be in force for the next 15 years.



The new brochure **"ARPEL in Perspective"** was developed with the seven strategic guidelines established by the Association for sustainable energy development. The Association ratified its accession and support to the **Global Compact Network Uruguay.** ARPEL is a member of the Global Compact since 2006 and has since then promoted its ten principles in its member companies.

The **Communications Plan of ARPEL for 2016-2018** was developed, with one of its main objectives being to communicate the achievements of the industry, thus working on its positioning and improvement of its reputation.

New editions of **ARPEL Newsletter** were released.



Significant presence in the media as of the organization of various events such as the **Seminar "Industrial Cybersecurity in a Technologically Dependent and Interconnected World"**, and the 88th Meeting of Experts (RANE) on "Reservoir Management."

The **new publications of ARPEL** were disseminated among the specialized media: Report "Trends of the Natural Gas Sector in Latin America and the Caribbean" and White Paper "Opportunities for the Development of Unconventional Oil and Gas in Latin America and the Caribbean."

Spaces for Dialogue Networking and New Business

ARPEL Conference 2017

During 2016 work was done in order to define the date, the motto, logistics, the agenda and the marketing plan of the Conference to be held April 25-27, 2017 in Punta del Este.

In its fifth edition, under the motto **"New Energy Reality - Challenges and Opportunities,"** it will bring together Presidents and CEOs of major companies and leading governmental authorities to present their vision on the new energy reality.

There will also be a business forum focused on the promotion of investment opportunities in exploration and production in Latin America and the Caribbean, in which State entities responsible for the regulation, promotion, bidding process and contracts in the oil and natural gas sector in the region will participate. Some of the issues that were identified in the agenda of the ARPEL 2017 Conference include: Prospects for the development of gas reserves in LAC; Challenges faced by the upstream sector in the new context of low prices: mature fields, unconventionals, offshore; The future of the oil and gas industry in the framework of the new global context; Global and regional economic and geopolitical vision and its impact on the energy sector; Smart Cities and mobility, new energy alternatives; Strategic importance of having an effective industrial cybersecurity program; The future of the refining and the petrochemical industry; and The labor force of the future, among others.

"A Brief Report Useful for the Hydrocarbon Agencies of the Region"

The document "A Brief Report Useful for the Hydrocarbon Agencies of the Region" was developed based on workshops conducted in Uruguay by Farouk Al Kassim, a geologist born in Iraq and nationalized Norwegian, who was one of the main responsible of the Norwegian Government in the development of the emerging oil industry in that country in the 1970s. This report was disseminated to all hydrocarbon agencies in the region and summarizes the key messages provided by a highly-qualified expert in the hydrocarbon industry that focused on good governance of natural resources to develop investment and create lasting wealth and sustainable development for the country that owns and develops such resources.
